

ICANN's Mission

The mission of the Internet Corporation for Assigned Names and Numbers (ICANN) is to ensure the stable and secure operation of the Internet's unique identifier systems

Specifically, ICANN:



Coordinates the allocation and assignment of names in the root zone of the Domain Name System



Coordinates the development and implementation of policies concerning the registration of second-level domain names in generic top-level domains (gTLDs)



Facilitates the coordination of the operation and evolution of the DNS root name server system



Coordinates the allocation and assignment at the top-most level of Internet Protocol numbers and Autonomous System numbers



Collaborates with other bodies as appropriate to provide registries needed for the functioning of the Internet as specified by Internet protocol standards development organizations

Universal Acceptance Initiative



Vision

All domain names and all email addresses work in all software applications

Mission

To mobilize the software application developers to get their products UA Ready by providing encouragement, documentation, case studies, tools and measures to deliver the right user experience to the end user

Impact

Promote consumer choice, improve competition and provide broader access to end users

o Internationalized domain names


Display is another problem, in addition to above

Should be correct for right-to-left scripts: مثال البحرين

- ⊙ Internationalized email addresses (EAI): अजय@डाटा.भारत (email address in Hindi language)
 - Available standards not implemented by all email software and service providers making email delivery unreliable
 - Test if your email is compliant: https://uasg.tech/eai-check/

Universal Acceptance Steering Group (UASG)



- To address the Universal Acceptance of domain names and email addresses, Universal Acceptance Steering Group (UASG) organized as a community imitative
- UASG has produced documentation to define, address the challenges and share progress, posted at https://UASG.tech, e.g.:

 - Quick Guide to Email Address Internationalization

 - Quick Guide to Tendering and Contractual Documents
- UASG is actively engaged in disseminating the information to relevant stakeholders

Universal Acceptance Steering Group (UASG) Structure



- UASG is a community-based group supported by ICANN org
 - Leadership Team: Chair and two to three Vice-chairs elected by the community
 - Coordination Group: UASG Leadership and chairs of all working groups
 - Working Groups: UASG community can opt for focused working groups
 - Community: General UASG community, interacting on UA-discuss email list

Action Plan for FY20: Universal Acceptance Steering Group (UASG)



Community Stakeholders



- Technology Enablers Organizations producing relevant standards and best current practices and providers of software programming languages, tools and frameworks
- Technology Developers Organizations and individuals developing and directing applications
- Email Software and Service Providers Organizations and individuals providing internationalized email software and services
- Influencing Individuals and Organizations Individuals at local and international level who can help promote UA Readiness, and organizations which can be used to spread the UA message more broadly
- Government Policy Makers Government officials, as an explicit group, are included to try to generate demand for UA Ready products and services through accessibility standards and procurement processes



UASG Working Groups



- Technology WG Plans, coordinates and oversees work on standards, best current practices, programming languages, tools and development platforms.
- Email Address Internationalization (EAI) WG Plans, executes and oversees engagement with email software and service providers to make them EAI Ready
- Measurements WG Plans, oversees and directs the measurement efforts for UA readiness
- Communications WG Plans and develops communication strategy and oversee its execution, in collaboration with other WGs
- Local Initiatives WG Plans, develops and oversees the execution of local initiatives in various geographies
- UA Ambassadors WG Plans and executes training and outreach in local regions

Local Initiatives



Purpose of Local Initiatives



In close consultation with UASG leadership and its working groups, and with the support and collaboration of ICANN org, undertake the following in the region:

Plan and undertake outreach to and collaborate with the stakeholders identified by UASG

Technology: Enablers and Developers

Email: Software and Service Providers

Influencers: Individuals and Organizations

Government: Policy Makers

Identify opportunities for and review the messaging and communications for local stakeholders

Identify relevant technical training requirements, audience and opportunities



Intended Geographies



- A region could span one or more countries and territories, as identified by the members of the local initiative
- Focus on regions which develop and export software products
 - o China
 - o EU
 - o India
 - o Russia
 - United States
- ⊙ Other regions based on community interest
 - Initial interest by
 - Middle East and Africa (MEA)
 - Latin America and Caribbean (LAC)
 - South East Europe (SEE)



Suggested Outcomes



- A local initiative may undertake many activities, which would generally fall under three areas:
 - Technical collaboration
 - General outreach
 - Public sector engagement



Suggested Outcomes: Technical Collaboration



- Focused on technical stakeholders, and may include technical training as well as collaboration with the local industry to implement UA Readiness practices
 - Collaborate with technology developing organizations to implement UA Readiness in their software development cycle
 - Collaborate with email service providers or organizations with their own email services to support EAI in their practice
 - Conduct technical trainings at relevant technical events and academic platforms on UA readiness for website/application development
 - Conduct technical trainings at relevant technical events and academic platforms on EAI
 Ready technologies and how to configure them to support EAI
 - Identify relevant local popular and e-government applications and web portals for testing UA Readiness
 - Develop EAI test-bed



Suggested Outcomes: General Outreach



- Focus on technical and non-technical audience to raise the awareness about UA challenges and its impact and to encourage adoption of UA Readiness
 - Enlist influencing organizations and influencing individuals to promote UA Readiness
 - Publish articles locally in technical and non-technical journals and magazines to promote UA
 Readiness among the stakeholders identified
 - Present on UA Readiness related topics at major technology events and conferences
 - Help develop case studies of UA readiness for technology development and EAI support,
 based on the collaborations given above



Suggested Outcomes: Public Sector Engagement



- Aim to raise awareness and to promote procurement policies and standards to support UA Readiness
 - Encourage Governmental Advisory Committee (GAC) members to help promote UA readiness nationally
 - Meet with national and local government policy makers for the following:
 - Discuss UA Readiness of local business and e-government websites
 - Encourage to update national procurement policy to include UA readiness requirements at least for e-government services
 - Interact with relevant standards bodies to discuss UA readiness and to encourage them to update national accessibility standards



Formation Process: Membership



- Local community members
 - o Chair
 - Software/web Developers
 - Software Project Managers and Architects
 - System Administrators, especially those managing email servers for organizations
 - Unicode and/or Localization Experts, with knowledge of local scripts
 - Communications and (technology) media experts
 - Marketing managers
 - Academia, Community and civil society members motivated with language and accessibility
 of internet
 - DNS and IDNA experts
 - TLD registries and registrars

- Proposal for Local Initiates
 - Introduction to the Region
 - Motivation for Starting the UASG Local Initiative in the Region
 - Members of the Local Initiative
 - Local Stakeholders
 - Overall Plan
 - Intended Outcomes

- Funding available to undertake specific activities based on a proposal document
